

OVERVIEW

CPD Principles

- Community building begins with job creation, employment, and creation of safe, decent and affordable housing.
- 2. Planning and execution of community development initiatives must be bottom up and community driven.
- Complex problems require coordinated, comprehensive, and sustainable solutions.
- Government must be streamlined to be made more efficient and effective.
- 5. Citizen participation in Federal, State and local government can be increased through communication and better access to information.

- Hurricane Matthew generated devastating flooding across central and eastern North Carolina on October 8 2016.
- Impacted entitlement communities: Fayetteville, Cumberland County, Goldsboro, Rocky Mount, Greenville, NC State Grantees, and New Bern
- The hurricane dumped more than a foot of rain 100 miles inland, swelling streams and rivers to levels above what Hurricane Floyd produced in 1999.
- The hardest hit counties were Cumberland, Robeson, Wayne, Johnston, Harnett, Lenoir, Nash and Edgecombe.
- At least 26 North Carolinians lost their lives. About 1 million homes were without power, some for days.

- Hundreds of roads were closed, including I-95 and I-40, and thousands of people were forced to leave their homes, some plucked from rooftops by the Coast Guard.
- FEMA was the first responder supplying immediate housing and other needs.
- HUD was actively involved serving families that were housed in Public Housing Units, Multi-Family Units, and providing support for entitlement communities and HOME Participating Jurisdictions.
- There many options for program waivers for the Community Development Block Grant and HOME Program. FHA Loan holders have many options and should contact lenders or housing counseling agencies in their respective.
